**Notification to call the Application for Admission of the Students in PhD Programme
for Academic Year -(2026/2027 A.D./ 2083/084 B.S.)**

This notification has been issued for submission of application form for the Ph.D. Programme for **10 seats only (8 seats for Nepali Citizens and 2 seats for foreigners)** for the Academic Year (2083-084 B.S.-2026/2027 A.D.).

Application form:

According to Regulation No.4 of Tribhuvan University, Faculty of Law, Ph.D. Program Operation Regulation, 2075, to be a candidate for the title of Ph.D. Award, Nepali Citizens or foreign citizens must fulfill the following qualifications.

- Master's Degree in Law (LL.M./M.L.) pass recognized by Tribhuvan University or a recognized University or at least second division pass in the equivalent degree or 3.0 CGPA or qualification completed as determined by the Higher Education Qualification Framework after passing equivalent grade.
- Having two years' experience after obtaining a Master's degree certificate in the concerned subject with a second division pass or 3.0 CGPA or equivalent grade.
- Having one year's experience after obtaining a Master's degree certificate in the concerned subject with a first division pass or 3.3 CGPA or equivalent grade.
- Experience shall not be mandatory for those candidates who have obtained a Master's degree with distinction division or 3.7 CGPA or equivalent grade.
- Candidates who want to be admitted for the Ph.D. must have published at least **two Peer Reviewed Articles**.

The following documents shall be submitted mandatorily along with the application form:

- Notarized photocopies of a transcript and certificate of SLC/SEE to Master Degree of Laws (LL.M.), citizenship certificate and character certificate.

- A photocopy of the certificate of equivalency from the Tribhuvan University (T.U.) for the degree awarded from foreign universities.
- At least **two peer reviewed** research articles published in a graded journal. However, only two articles shall be evaluated if submitted more than two.
- Three copies of certificate of experiences and bio-data.
- The applicants submitting the application form for admission shall deposit in total **Rs. 13000/** which includes **Rs.3000/** fee for the application form, Rs. 5000/ fee for Entrance Examination and **Rs. 5000/** fee for evaluation of articles.
- An application form can be collected from the Office of the Dean, Faculty of Law, Balkhu, Kathmandu, upon submission of the original voucher for the total fee of Rs.13,000/- (in words thirteen thousand rupees) only as determined by the Faculty of Law.
- The original voucher should be submitted after depositing the above amount in the **Current Account Number: 21700100192434000001** of the Nepal Bank Limited of **KANOON SANKAYA DIN KARYALAYA**.
- The application form shall not be entertained if the criteria are not fulfilled; if the documents are not submitted as prescribed to establish the evidence and if the application is submitted after the expiry of the date.
- In total, Entrance Examination shall be of **100 marks** which include **80 marks** for written Examination, **10 marks** for evaluation of articles and **10 marks** for interview.
- Subjective subjects of **Jurisprudence and Research Methodology** at postgraduate (LL..M./M.L.) level have been determined for the entrance examination. In the entrance exam, there will be a written entrance exam of total **80 marks with 40 marks from Jurisprudence** subject and **40 marks from Research Methodology** subject.

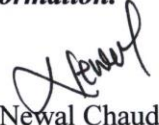
Distribution of application form, date of registration and time:
