

Submission Guidelines

- The manuscripts shall be between 5000-8000 words excluding footnotes. The nature of submission shall be full length article, short case commentaries, law reviewed, case analysis and other within the discourse of legal fraternity.
- The manuscripts must be accompanied by an abstract. It can be up to 300 words with 5 major key words. The abstract must mention rational of research, methodologies, findings and recommendation.
- The manuscripts may be authored by up to 2 co-authors. In case submission with co-author, the initial author name will be used for the different purpose in the journal.
- All works must be original and unpublished, and must not be pending for review before any other journal. Plagiarism beyond 10% shall not be accepted.
- The manuscripts must be submitted in Microsoft word format with proper structure and typo.
- The main body of the paper should be in Times New Roman style, font size 12, with 1.5 line spacing, and footnotes in Times New Roman Style, Size 10, with 1.0 line spacing. All headings must have uniform formatting.
- Each author is mandatory required to follow *TU Research Guidelines, 2023* for their paper and Bluebook reference style, 2021.
- TU Faculty of Law shall be the sole copyright owner of all the published materials.
- The Editorial board reserves the right to make final decisions regarding the conditions, guidelines and publication mentioned herein.
- The manuscripts shall be submitted to journal@fol.edu.np
- The submission deadline is 10th February 2024 (*Magh, 27th 2080 B.S.*)
