(23rd Feb, 2024 A.D.) during office hours.

6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 12th Falgun, 2080 B.S. (24th Feb, 2024 A.D.), 2:00 PM at the office of Doti Multiple Campus, Silgadhi, Doti.

Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of Nrs. 24,690 (In words Twenty Four Thousand Six Hundred Ninety Rupees Only), which shall be valid for 30 days beyond the validity period of the bid (i.e. 75 days from date of opening).
