## सूचना !

यस विभागबाट वार्षिक रूपमा प्रकाशन गरिने विज्ञ संपरीक्षित (Peer-Reviewed) **Journal of Buddhist Studies (T.U.)**, भोल्युम-३, अंक-३ नामक जर्नलको लागि लेख पठाउने मिति २०८२ पुष मसान्त भित्रमा लेखरचनाहरू विभागको Email: [info@cdfs.tu.edu.np](mailto:info@cdfs.tu.edu.np) मा इमेल गरि, दुई प्रति हार्डकपी यस विभागमा बुझाउनुहुन अनुरोध गरिन्छ। लेखरचनाहरू तपशिल निर्देशिकामा आधारित हुनुपर्ने छ।

### तपशिल:

1. Research articles should either be in English or Nepali Language.
2. The articles should be original and previously unpublished in print, electronic or any media whatsoever.
3. Research articles for 'Journal of Buddhist Studies (T.U.)' should be related to Buddhist philosophy, Engaged Buddhism (psychology, education, environment, medicine, management etc.), Mindfulness, Buddhist history, archaeology, and culture, Buddhist arts, Iconography and architecture, Buddhist tourism, pilgrimage, and heritage, Buddhist literature, practices and festivals and Buddhist communities.
4. Priorities is given to the research articles related to above genres which investigate on unexplored issues or new information, original concepts, theories that reflect a clear and significant contribution.
5. To prepare research manuscripts, authors should follow basic guidelines of research ethics and writing mechanics with clear title, abstract (maximum of 200 words), Keywords, introduction, methodology, discussion and conclusion.
6. Authors are encouraged to endure that their in-text citations and references adhered to the APA 7<sup>th</sup> format.
7. Author's name should only be in cover page. It should not be disclosed in the manuscript.
8. Articles should not exceed 5000 words including everything (title, abstracts, table, citations and references). Neatly typed on only one-side in A4 paper with font sizes (12 Times New Roman for English) and (16 Preeti or kokila) for Nepali) and 2.5 cm margins on all sides are mandatory requirements for research format.

13. The editorial board reserves the right to edit, accept or reject the articles and the board's decision regarding the publication shall be final.
