for Academic Year -(2023/2024 A.D./ 2079/080 B.S.)**

This notification has been issued for submission of application form for the Ph.D. Programme for 10 seats only (8 seats for Nepali Citizens and 2 seats for foreigners) for the Academic Year (2079-080-2023/2024).

**Application form:**

The application form can be collected from the Office of the Dean, Faculty of Law, Balkhu, Kathmandu after submitting the original voucher of the fee deposited as prescribed below.

**The qualification of the candidates, who shall apply, shall be as follows:**

- At least second division in the subject of law at master level.
- Two years (work) experience for the person who has passed with second division, one year experience for the person who has passed first division and there will be no need of experience for the person who has passed with distinction.
- At least two peer reviewed research articles published in a graded journal.

**The following documents shall be submitted mandatorily along with the application form:**

- The research scholar pursuing Ph.D. study shall be of the full time students. Therefore, a letter of prior leave approval sanctioned by the Chief of the institution or departments.
- Notarized photocopies of a transcript and certificate of Master Degree of Laws (LL.M.), citizenship certificate and character certificate.
- A photocopy of the certificate of equivalency from the Tribhuvan University (T.U.) for the degree awarded from foreign universities.
- At least two peer reviewed research articles published in a graded journal. However, only two articles shall be evaluated if submitted more than two.
- Three copies of certificate of experiences and bio-data.

- The applicants submitting the application form for admission shall deposit in total Rs. 13000/ which includes Rs.3000/ fee for the application form, Rs. 5000/ fee for Entrance Examination and Rs. 5000/ fee for evaluation of articles.
- The original voucher should be submitted after depositing the above amount in the **Current Account Number: 21700100192434000001** of the Nepal Bank Limited of the Office of the Dean, Faculty of Law.
- The application form shall not be entertained if the criteria are not fulfilled; if the documents are not submitted as prescribed to establish the evidence and if the application is submitted after the expiry of the date.
- In total, Entrance Examination shall be of 100 marks which include 80 marks for written Examination, 10 marks for evaluation of articles and 10 marks for interview.
- The Office of the Dean, Faculty of Law shall be contacted for syllabus of Entrance Examination including other information.

The written Entrance Examination shall be held on 2082/09/12 (December 27, 2025), Saturday, at Faculty of Law, Dean's office, Balkhu, Kathmandu from 11:00 am to 2:00 pm.
